ARTICLES OF INCORPORATION
OF
PART-TIME FACULTY ASSOCIATION
OF THE MARICOPA COUNTY
COMMUNITY COLLEGE DISTRICT,
INC.

KNOW ALL MEN BY THESE PRESENTS:
That we, the undersigned, have this day associated ourselves together for the purpose of forming a non-profit Corporation under the laws of the State of Arizona for the purpose of having said State Article of Incorporation.

ARTICLE I
The name of the Corporation shall be: PART-TIME FACULTY ASSOCIATION OF THE MARICOPA COUNTY COMMUNITY COLLEGE DISTRICT, INC.

ARTICLE II
The principal place of business shall be Phoenix, Maricopa County, Arizona.

ARTICLE III
The purpose for which this Corporation is organized is the promotion of any or all lawful business which non-profit corporations may be incorporated under the laws of the State of Arizona, as they may be amended here to in time.

ARTICLE IV
The Corporation is organized exclusively to establish a non-profit association of Part-time employees to include, necessary, and other educational institutions and Section 501 (c)(3) of the Internal Revenue Code of 1954, provided for such purpose the members of organizations or organizations that are not organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law.

ARTICLE V
No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, officers, directors, or other private inclusions, except that the Corporation shall be authorized and empowered to pay the annual meeting to be held at a place within or without the state as fixed by the bylaws.
